
: Policy for Mechanism of Internal Women's grievance redressal with reference to complaints of sexual harassment:

- The college shall follow and abide by Harassment at workplace (prevention ,prohibition and redressal ) Act 2013 in case of any complaint by woman employee or student.
- The college shall establish a committee for grievance redressal for complaints of sexual harassment as per Vishakha judgement .
- The college shall organize workshops and programmes to create awareness against sexual harassment .
- The college shall display helpline numbers on flex board for students for reporting of complaint of sexual harassment.
- Dress code and Identity cards shall be compulsory for all students in college campus .

Discussion was held on working mechanism and procedure of the committee .A number of suggestions were received from members .



As there were no subjects for discussion ,the co-ordinator declared that the meeting has ended.




## Action taken Report of Internal women's Grievance Redressal Committee during 2017-18


Internal women's Grievance Redressal Committee of the college organized following activities during 2017-18 .

**Subject No. 2 : About organizing gender sensitization programme**




- 06 students expressed their views and 14 students participated in poster presentation .



- The programme made great influence on the students .



**Outcomes :**


- Sixty four students participated in the programme .

The Internal Women's Grievance redressal Committee has evolved following Gender Sensitization Action plan in the meeting held on 10 January 2022.

**-Action Plan for Gender Sensitization -**

The college is committed to gender equity and promotion in the campus .It has taken measures to propagate gender sensitization among students in various ways during 2021-22 :


- (A) **Active Cell** : Anti sexual Harassment and Internal Womens' Grievance Cell is active in the college. It held two meetings on 10/1/22 and 02/3/2022 to organize various activities .
- (B) **Health and Hygiene** : The NSS unit of the college conducted two surveys on women's hygiene awareness at village Porgavan and Lahan Arvi on 3<sup>rd</sup> January and 24 March 2022. In all 24 volunteers participated in the survey. They surveyed 210 women in these villages .The objective of survey was to create awareness about use of sanitary pads during menstruation period.
- (C) **Gender Sensitization** : A programme was organized by the cell on **08 March 2022** i.e. International Womens' Day "**Gender Awareness and Responsibility of Youth**". Ku. Pratiksha Dapurkar, social activist was the resource person. The students were divided into 07 groups for group discussion. Total 74 students were present in the programme .
- (D) **Workshop on Womens' Safety** : The students should know about various laws related to gender equity and promotion .They should realize that all citizens ,whether male or female ,are respectable .Gender discrimination cannot be tolerated at any cost at all levels. In this

regard, the college organized a legal awareness camp in collaboration with Taluka Vidhi Seva Samiti, Ashti on **17 January 2022**. Hon'ble Judge of Ashti Court Shri M.J. Mohod was Chairman of the programme. Speakers in the programme focussed on various laws like POCSO, laws related women's rights etc.

(E) **National Girl Child Day** : A symposium was organized on National Girl Child Day in the college. Four students expressed their thoughts on issues like laws on domestic violence, social status of women in India, imbalance in male and female ratio, sexual discrimination against women etc. Chief guest Mrs. Pratiksh Dapurkar social worker from Krantijyoti Samajik Sanstha, Pune expressed that even in 21<sup>st</sup> century, the attitude of society to look towards women's issues has not changed. There is a need for society to introspect and bring about a change.

(F) **Facilities for Girl students**: The college has separate toilet and common room facility for girl students. The medical tests of all girl students are conducted by a lady doctor every year according to rules of RTM Nagpur University. **210** girl students appeared for medical test during 24 April to 02 May 2022.


The composition of the cell is as follows for 2021-22 and 22-23:
